With the recent change in school leadership, Collegiate Charter High School of Los Angeles Administrative Team, has taken numerous steps to ensure a seamless transition for its staff, students, and parents/families and has met with community members on multiple occasions to solicit input and feedback on the school's programming, return to in-person instruction, discuss the school's LCAP, assess schoolwide needs, and most recently with the development of this plan.

Collegiate Charter High School solicited input from students during discussions in their leadership course. Collegiate's Administrative Team also meaningfully consulted with families/parents/guardians, including those representing Unduplicated Pupils (English Learners, Low-income, foster youth); Students with Disabilities (SWD); and those who speak languages other than English, during Monthly Team meetings and most recently the Family Chat Meeting that took place on September 29th. In addition, surveys written in English and Spanish, were administered to families/guardians to ensure opportunities for public input in the development of this plan were solicited. Accommodations as appropriate were also made for family members with disabilities including providing information and school reports in a format (to the extent practicable) in a language that parents understand.

School Administrators including the Executive Director and Principal, met weekly during the summer and continued this fall to develop a needs assessments using multiple types of schoolwide and student achievement data to make an informed decision in determining the prevention and mitigation strategies; including strategies to address the academic impact of lost instructional time, and other strategies or activities to be implemented. Meaningful consultation with the Dean of Special Services (Special Education Administrator) took place during bi-weekly meetings to discuss and address the academic impact of lost instructional time for Students with Disabilities.

Teachers, Paraprofessionals, Support Staff, Classified Staff, Homeless/Foster Youth Liaison were consulted during staff development meetings and professional development to provide multiple venues for public input.

Community Members, Expanded Learning Providers, and Other Community-based Organizations including – Cross Country, MindsMatter, and PUC SEL Counseling.

Collegiate Charter High School of Los Angeles evaluated its community member engagement opportunities and determined that tribes, Civil Rights Organizations including Disability Rights Organizations and Individuals/advocates representing interests of English Learners, Homeless, foster youth, migratory students, Students with Disabilities, children who are incarcerated and underserved students were neither present nor currently served by the school.

A description of how the development of the plan was influenced by community input.

Collegiate Charter High School of Los Angeles ESSER III Expenditure Plan was influenced by the input and feedback provided in consultation with community members, with a focus on addressing students' academic, social, emotional, and mental health needs, and address opportunity gaps that existed before, and were further exacerbated by the COVID-19 pandemic.

Feedback provided from community input includes:

- Hire substitute teachers for the immediate placement when teachers are absent; and/or when participating in professional development
- Hire an additional Academic Counselor to reduce Counselor to student ratio, and to identify and meet with students/families that are credit deficient or at risk of not graduating. As a college preparatory high school, our goal is for every student to graduate, meet UC A-G eligibility requirements, demonstrate grade level content standards, and be prepared to succeed in post-secondary education with life skills.
- Extended School Year/Intervention: Winter Academy; and Summer School Credit Recovery
- Additional academic support in ELA – implement a College Readiness course
- Significant concerns from families, students, and teachers that students need additional support/interventions and opportunities to retake courses students have failed.
- Provide additional SEL Support – MTSS Program
- Provide field trips, sports programs – once it is safe to do so
- Strengthen Math & Science instruction to ensure students are “college ready

Collegiate Charter High School of Los Angeles analyzed input from community members in combination with multiple types of schoolwide/student/student group data, and the school's LCAP annual measurable outcomes and the following actions were identified as a priority to be funded with ESSER III funds:

- Strategies for Safe and In-Person Learning
 - Campus Aides to administer COVID-19 Testing, contact tracing, etc.
- Addressing the Impact of Lost Instructional Time
 - Winter Intercession Academy; Summer School Academy; and additional Academic Counselor
 - Social-emotional Counseling services for students

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 3 – Promising Evidence:** the effectiveness of the practices or programs is supported by one or more well-designed and well-implemented correlational studies (with statistical controls for selection bias).
 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

 - Progress monitoring to ensure interventions address the academic, social, emotional, and mental health needs for all students, especially those students disproportionately impacted by COVID-19

Planned Actions and Expenditures

Purpose and Requirements

As noted in the Introduction, an LEA receiving ESSER III funds is required to develop a plan to use its ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

Instructions
